It is also a criminal offence to knowingly provide information that is false or misleading (or being reckless as to whether the information is true and not misleading)

In addition to the above, the Council has adopted a Code of Conduct for Members which requires you to notify the Monitoring Officer of any DPIs before the end of 28 days beginning with the day on which the Code takes effect. In the interests of transparency, it would also require declaration of DPIs at meetings even where they have been registered. Failure to comply with these requirements would not be a criminal offence but would be a breach of the code of conduct.
